- Alternatively, we offer the possibility of collection by a Shuttle bus for 8 persons from Airport Münster-Osnabück to Schloß Danker for EUR 225,00 one way.

Airport Düsseldorf (DUS) in the distance of 200 km

There are the following possibilities to travel to Schloß Dankern:

- By train (approx. 3 hrs.) from Airport Düsseldorf over Münster (Westf) Hbf to Meppen (approx. EUR 45,00 per person). Shuttle bus free of charge from Meppen to Schloß Dankern.
- Alternatively, we offer the possibility of collection by a Shuttle bus for 8 persons from Airport Düsseldorf to Schloß Danker for EUR 425,00 one way.

Airport Amsterdam Schiphol (AMS) in the distance of 230 km

There are the following possibilities to travel to Schloß Dankern:

- By train (approx. 2 hrs.) from Schiphol over Zwolle, Marienburg to Emmen South (approx. EUR 25,00 per person). Shuttle bus free of charge from Emmen South to Schloß Dankern.

The organizing club or federation does not undertake any liability for damage to persons, material or property against competitors, technical officer, judges, official assistants and other persons. All competitors take part on their own risk



in every respect even if they are engaged out of the competition, e.g. in any additional program. With the entry of the competition they give up any claim from cases of loss of any kind arising indirectly or directly during this event. Athletes ought to have a private accident insurance beside their health insurance. Damage to a third party (e.g. spectators) is insured only within the limits of the organizer's liability.

In accordance with the IWWF anti-Doping Rules, drugs controls will be conducted during the competition. In entering this competition, all athletes agree to be subject to doping control.
