Cable ski coaches and trainers are welcome as there is a good crossover of skills and techniques. This Seminar is geared towards beginner and intermediate coaching up to an early international level. The coaches' seminar will be run 11th / 12<sup>th</sup> May 2013 in English.

In the same time, there will be a tournament judges' seminar aimed at developing people as judges. The seminar will cover the rules and the judge's role over the 3 events (slalom, trick and jump) with the aim to run and judge competitions up to International Level.

Additionally, there will be an opportunity for an Asian International Judge Qualification exam on Monday 13th May 2013.
